Conclusion on the assessment of the corporate governance system of Joint - Stock Company «UZBEK COMMODITY EXCHANGE» has been prepared by the «CITY CAPITAL» LLC.

An independent assessment of the corporate governance system of JSC «UZEX» was conducted according to the agreement № 1/V of February 14, 2022. The independent evaluation was carried out in accordance with the legislation of the Republic of Uzbekistan, including the Corporate Governance Code approved by the Commission on increasing the efficiency of joint stock companies and improving the corporate governance system (Minutes No.9 of December 31, 2015).

The purpose of assessment is formation of independent objective opinion on the status of corporate governance system in JSC «UZEX».

Assessment of corporate governance system in JSC «UZEX» was conducted on the basis of Questionnaire approved by the State Competition Committee of the Republic of Uzbekistan and Scientific and educational center for corporate governance dated July 25, 2016.

«CITY CAPITAL» LLC is responsible only for expressing its opinion on the status of corporate governance in JSC «UZEX», based on the documents, reports, information and other materials provided by the Company.

Responsibility for the completeness, content and reliability of the submitted documents, reports, information and other materials is borne by JSC «UZEX». The authenticity and reliability of the received documents, reports, information and other materials was not checked and not contested.

«CITY CAPITAL» LLC confirms that the documents, reports, information and other materials provided by the Company provide are sufficient for expressing an independent opinion on the state of corporate governance in JSC «UZEX».

Based on the results of the assessment of the corporate governance system, the actual valuation of JSC «UZEX» is 1 165 points or 97,08% according to the percentage scale and, according to «CITY CAPITAL» LLC, the level of the corporate governance system in the Company is recognized as whigh», while in the context of directions looks as follow:
